3. CoNNMO Chair Secretarial Update

- Julianne Bryce, former CoNNMO Secretariat, has left ANMF after 18 years of service to the nursing profession in this role. Julianne was thanked for her dedication and contribution to CoNNMO. Naomi Riley, ANMF Strategic Lead – Midwifery, will act as Secretariat moving forward.
- Nominations for two Council positions will be sought by the Secretariat in June 2025. These Council positions are currently held by Joanne Perks and Samantha Moses. This is Joanne Perks' third term on Council and due to the rules under the Terms of Reference, she will be unable to renominate for a position. CoNNMO council would like to acknowledge and thank Jo for her contribution to CoNNMO as a Council member over the past 6 years and Council Chair since August 2023. Samantha Moses, having service two consecutive terms on Council will be eligible to re-nominate for a vacant position. CoNNMO member representatives that have attended a minimum of two member meetings, as a representative or observer will be encouraged to nominate.
- No new membership applications or withdrawals have occurred since the last meeting and currently there are 63 member organisations in CoNNMO.
- Updated Secretariat and Chair reports, along with a corrected attendance list, will be made available on the CoNNMO website, along with the meeting minutes and CoNNMO member reports

4. Commonwealth Chief Nursing and Midwifery Officer update Adjunct Professor (Practice) Alison McMillan PSM CCNMO

- The department has been restructured to include Health, Disability and Ageing under one umbrella.
- Discussed departmental priorities, including a strong focus on health equity, prevention, and workforce development.
- Challenges remain in private maternity hospital viability, with nursing and midwifery organisations actively involved in addressing these issues.
- In Aged Care, improvements include mandatory 24/7 registered nurses and infection prevention control nurses. Vaccination coverage remains a concern.
- Expanded access for nurse practitioners and endorsed midwives to prescribe under PBS and access MBS
- Designated nurse prescribing is expected to commence by July 2026.
- Introduction of a professional indemnity insurance (PII) product underwritten by the Commonwealth Government for privately practising midwives to include intrapartum care and homebirth to be available from July 1, 2025. Exemption for PII for midwives providing intrapartum care and homebirths to remain until June 30, 2026.
- The National Nursing Workforce Strategy is expected to be signed off by the Prime Minister soon.
- Emphasis on community-based, proactive healthcare models to improve access, especially in rural, remote, and Indigenous communities.

5. Commonwealth Department of Health Disability and Ageing update Natalie Bekis, Assistant Secretary

 Natalie provided updates on recent reviews and the establishment of a taskforce to prioritise and coordinate over 70 recommendations evolving from these. Key elements are addressing challenges in primary health care, utilising the full scope of practitioners to deliver efficiencies in care, improved funding models, digital integration, and garnering consumer support.



- She outlined the Complexity Review of the National Scheme (NRAS), led by Sue Dawson, addressing
 governance, regulation across professions, and proposed changes to complaints handling, with a final
 report due mid-year.
- Updates on the international workforce included streamlined pathways for nurses from five countries
 to gain registration in Australia and faster medical practitioner registration processes, alongside efforts
 to balance this with strengthening the domestic workforce and addressing high nurse and midwife
 attrition.
- The National Maternity Workforce Strategy, led by QLD and NSW Governments, is progressing, with the first steering committee meeting, following a number of consultations/forums across Australia over the past 6-8 weeks, to be held on May 29, 2025. Discussions are ongoing around election commitments, including funding for a Chief Midwife and a national midwifery strategy.
- Mental health and disability portfolios are being integrated, with advocacy planned for stronger support for mental health and disability nursing.
- Finally, the nationwide rollout of the Nurse and Midwife Health Program was acknowledged, now offering free support through state-based hubs.

6. Nursing and Midwifery Board of Australia update Alessandra Peck, CEO (via teleconference)

- Alley provided an update on current regulatory priorities and highlighted the board's partnership with CATSINaM to support culturally safe care and eliminate racism in healthcare, including a joint video project to be launched in Darwin.
- Reviews of standards, codes, and guidelines are underway to reflect these priorities.
- Draft standards for RN prescribing endorsement and a new registration pathway for internationally qualified nurses are progressing.
- Objective Structure Clinical Exam (OSCE) expansion to Melbourne and Adelaide is underway, with new self-paced prep programs and a national assessment model being explored.
- Final cosmetic procedure guidelines for nurses are nearing completion.
- Updates also included: dual RN-paramedic registration, changes to recency of practice and CPD standards, and nurse practitioner endorsement consultation.
- Collaboration with Monash University is ongoing to revise RN and EN practice standards, with broader consultation planned for late 2025.
- Despite challenges with the new case management and MFA login systems, over 250,000 nurses and midwives have registered, and late fees are waived until mid-June.

7. Australian Nursing and Midwifery Accreditation Council update Tanya Vogt, CEO

- Tanya provided an update on key accreditation developments and highlighted a shift to a risk-based, streamlined reaccreditation process, especially for established universities.
- Double degrees linking nursing with other fields are growing, but the focus remains on the RN qualification.
- ANMAC is reviewing RN and EN accreditation standards, especially cultural safety, clinical placement



quality, and foundational education levels.

- Designated RN prescribing is progressing, with new accreditation standards in place, but broader implementation such as PBS access requires legal changes.
- ANMAC is collaborating with the Council of Deans of Nursing and Midwifery (CDNM) and universities
 to develop standards and real-time evaluation tools to improve clinical supervision and placement
 experiences for students.
- ANMAC is also involved in Aboriginal-led assessor training and is working on real-time clinical placement evaluation tools.

8. Australian Nursing & Midwifery Accreditation Council update Kath Baird, Director of School Migration Services

- Kath shared an update on Health Education Services Australia's (HESA) work since its establishment in 2018.
- HESA focuses on developing and accrediting education standards for immunisation programs since 2020 and runs the National Placement Evaluation Centre acquired in 2022 to evaluate nursing and midwifery student placements.
- In 2024, they began collecting supervisor evaluation data and will soon publish a summary report.
- Recently re-established as a not-for-profit entity, HESA aims to set postgraduate education standards in nursing and midwifery, with plans to partner with industry groups and expand accreditation to other health professions.
- They also plan to introduce an online register for accredited programs and graduates to assure quality and support workforce development, particularly in areas like rural health, maternal and child health, and aged care education.

9. Australian Nursing and Midwifery Federation update Annie Butler, Federal Secretary

- Annie acknowledged the impact of current NSW floods on health workers and highlighted the ANMF's
 new Climate Change Officer role, funded through a CANA grant, to strengthen national coordination
 on the health impacts of climate change.
- Acknowledged the humanitarian crisis in Gaza and ANMF's recent public statement in support of healthcare workers affected by global conflicts.
- Concerns were raised about proposed nursing apprenticeships, warning of significant professional and industrial risks, particularly to pay and conditions.
- Provided updates on aged care reforms, including the new Aged Care Act effective from 1 July, 2025, rights-based care, and ongoing work around education, training, and implementation of RN 24/7 requirements.
- Provided an update on the ANMF Work Value Case and the launch of a second case affecting nurses outside state systems, including in private hospitals and primary care. She highlighted growing employer resistance and noted the upcoming Fair Work Commission conference is scheduled for 17 June.



• Noted the importance of political engagement, celebrating wins like fee-free TAFE and support for student placements under the current federal government.

10. Al in Digital Health Jen Bichel Findlay, Nursing Midwifery in Digital Health Network representative

- Jen was invited to complete the presentation that was cut short at the October 2024 member meeting.
- Presented how AI handles repetitive tasks better than humans
- Explore the use of chatbots—Al programs that simulate conversation and their growing role in healthcare beyond customer service. Unlike basic bots, health chatbots are backed by clinical literature and used in symptom checking, mental health, chronic pain, and aged care. Key examples include Call Me, Milo, Bungie, Wysa, Wobot Health, Dolores (used for pain and child abuse detection), Holly (tracks Parkinson's progression), Edna (genetic testing), and Quinn (smoking cessation).
- The session also introduced Generative AI, which creates personalized care plans, documents, and
 patient education using predictive algorithms, but requires human oversight to avoid errors or
 hallucinations.
- Tools like Otter.ai, Read.ai, and SmartScribe were shared as practical Al applications for real-time meeting transcription, along with emerging use in sentiment analysis.
- Noted the practical use of AI in healthcare, especially how tools like ChatGPT can efficiently extract relevant information. Key platforms mentioned include Microsoft Copilot, Google Gemini, and OpenAI tools, with ongoing concerns about hallucinations, bias, and lack of regulation.
- Shortcomings of AI and ethical issues were briefly explored including the lack of content reflecting Aboriginal and Torres Strait Islander peoples' experiences available to AI, and the need for nurse involvement in AI development.
- Predictive modeling in wound care, mental health, and community nursing was emphasised as the future, supported by examples of Al applications in diagnostics and patient triage.
- Rhonda Wilson shared updates from RMIT on mental health AI research and stressed inclusive, regulated development.

• The Australian College of Mental Health Nurses' representative noted their international conference is scheduled for September 2025 in Brisbane, and the global mental health nursing summit will be held in November 2025 in Barcelona.

12. Other Business

13. Australian Digital Health Agency Update Karen Booth, Chief Clinical Advisor (Nursing)

- Karen discussed key strategic documents including the National Digital Health Strategy, the Interoperability Plan, and the Healthcare Identifiers Roadmap.
- Efforts are underway to provide better My Health Record access to allied health professionals, who currently face limited integration.
- Key updates included the implementation of the "Share by Default" legislation to ensure health data like pathology and imaging results are uploaded to MHR, and the expansion of digital health in aged care, including improved clinical handover and access to patient data.
- Updated on the My Health App, which is positioned as the "digital front door." The app allows
 consumers to access scripts, results, and add personal health information. There are plans to add
 My Medicare registration and advance care planning support.
- 40–50% of aged care homes are now connected to MHR. Efforts continue to improve clinical handovers and digital access in aged care, including allowing ENs to contribute more effectively to records.
- Future plans involve developing a new dynamic national platform to allow real-time, interoperable communication across hospital, GP, and other health systems, plus integration of real-time prescription monitoring.



14. Florence by APNA – a new Continuing Professional Development tool Mitch Wall Australian Primary Health Care Nurses Association,

- Mitch introduced *Florence*, a new, free professional development and career growth app designed by APNA for nurses.
- Launched 10 days ago, Florence already has several thousand users and over 11,000 CPD activities logged.
- The app aims to transform CPD from a basic compliance task into a meaningful, strategic career tool.
 It allows nurses to easily record CPD activities via multiple methods including QR codes, URLs, or
 manual entry and provides personalised CPD recommendations based on their role, setting, and
 goals.
- Nurses can also set SMART goals, build and share learning collections, and compare their expertise with other peers using dynamic skill graphs.
- Florence serves not only individuals but also the broader health system by generating real-time workforce insights to support planning, retention, and reform.
- It is designed to be inclusive, culturally aware, and continually evolving based on user feedback. The platform will soon support employer and research engagement by matching opportunities with relevant nurse profiles.
